## At the Bargaining Table

### Members of Civil Service ratify new five-year agreement

On Thursday, January 28, the Civil Service Bargaining Committee finished counting all ballots and the majority of members voted to ratify a new five-year collective agreement.

In early summer 2015, after failing to get a fair and reasonable offer from the employer, the Bargaining Committee decided to proceed to arbitration, where a third-party arbitrator would hear arguments from both sides and then impose a binding settlement.

While arbitration dates were set for spring 2016, the Bargaining Committee kept up the pressure on the Province. The union organized rallies, ran advertising campaigns and met with MLAs, arguing that a negotiated settlement is always preferable and a fair and reasonable offer not too much to ask.

After MGEU members flooded the Legislative gallery in a sea of red t-shirts that

said "Still Without a Contract" on December 1, 2015, the employer finally agreed to a return to the table. After a number of back-and-forth meetings, the sides reached a tentative agreement on December 30, 2015.

The Bargaining Committee made a neutral recommendation to members, opting to hold information meetings across the province to explain the pros and cons of the two options — accept the tentative agreement or proceed to arbitration.

The new five-year agreement includes general wage increases over the course of the agreement, a fund for special wage adjustments, and expanded job security.

The new Civil Service agreement will likely mean that several other Locals, who've been waiting for a funding mandate from the Province can move forward with negotiations.

### MPI, health professionals to continue negotiations with aid of conciliator

In January, the employer informed the **MPI Bargaining Committee** that they had applied for conciliation. The Bargaining

Committee did not believe they had reached an impasse, but did agree that the process could be helpful, and bargaining dates with the conciliator have been scheduled into February.

Meanwhile, the **Technical Professional/EMS/Diagnostic Services of MB** Central Table Bargaining Committee began discussing monetary proposals for the first time in January when the employer decided it would be beneficial to request the aid of the conciliator. Negotiations with the conciliator are scheduled to resume in February.

In January, I spoke to several media outlets, including CBC, CJOB, and Global News about the Civil Service tentative agreement. Several business lobby groups had plenty to say about the agreement's no lay-off clause, suggesting it was fiscally irresponsible of the government. Over and over, I reiterated that Manitoba's public services are already lean and our members have been doing more with less for years. Polls show Manitobans value their public services above all and cuts and privatization are what's truly irresponsible.
