MORE ON FRONT LINE TO GET VACCINE, STILL MORE MUST BE ADDED

On Dec. 24, I told the **Wpg Free Press** that we were encouraged to see more front-line workers added to the next group of those to get the COVID-19 vaccine, but we're looking forward to even more of our members being added to the list in future.

GOV MUST REVERSE DECISION STRIPPING NEW MOMS OF ONE WEEK MATERNITY PAY

On Dec. 10, I told the **CBC** that the MGEU is calling on the government



to reverse a shocking decision that would strip new moms who work for Manitoba's Civil Service of a week's maternity pay.

By refusing to do so, they are robbing young Manitobans with growing families of a benefit that comes at no increased cost to them as an employer.

PROVINCE MUST SET REMOTE WORK EXAMPLE

On Dec. 3, I told the **CBC** that the MGEU has filed a grievance with the Province because some Civil Service managers aren't following Dr. Brent Roussin's guidance to work from home to protect as many Manitobans as possible.

"KEEPING LIQUOR PUBLIC" TAKES AIM AT PALLISTER'S LATEST PRIVATIZATION PLANS



On Dec. 14, we relaunched the *Keeping Liquor Public* campaign in response to Pallister's plan to privatize more liquor sales in Manitoba. More than \$280 million in profits every year generated by Liquor Marts are invested back into public services, like schools, hospitals, and roads (not funneled to out-of-province shareholders);

At the Bargaining Table

BILL 28 APPEAL, REMEDY PROCESS CONTINUES

Having lost in court in June, the Pallister government appealed the court's ruling against its restrictive wage freeze law (Bill 28). The government is expected to submit supporting documentation for its appeal later this month and the Partnership to Defend Public Services (PDPS) (which includes the MGEU and other public-sector unions) will have 30 days to respond. The government's appeal will be heard in court this spring.

Dates in Nov. 2021 have also been set for the second part of the Court of Queen's Bench trial, to determine additional remedies that go beyond having Bill 28 struck down. Meanwhile, the MGEU and the other PDPS partners continue to focus on trying to get Locals back to the bargaining table.

RATIFICATION REVIEW

Members of **Elizabeth Fry Society of MB - Local 301**, who provide advocacy and support to women who are in conflict with the law, and **Tamarack Rehabilitation - Local 157**, who provide addictions treatment and recovery services, both ratified new agreements in December.
