## At the Bargaining Table: ENOUGH IS ENOUGH!

Thursday, May 28 through Sunday, May 31, 2015, many of your MGEU leaders and activists attended the Manitoba Federation of Labour Convention in Brandon.

**While there, we took the opportunity to send a clear and united message to Premier Greg Selinger: Enough is enough! It's time for a fair and reasonable offer!**

Donning "Still Without a Contract" stickers, your leadership, activists, and delegates from other unions reminded the Premier that nearly 25,000 MGEU members have been without a new contract for over a year, with some as many as two years.

The Civil Service, Community Support and Local 220, the Technical/Professional/Paramedical Central Table, the All-Nations Coordinated Response Network, Manitoba Housing, the Addictions Foundation of Manitoba — thousands of our members who provide the day-to-day services that Manitobans rely on — remain in limbo at the bargaining table.

We reminded him that our members accepted wage freezes only to see 5% of their co-workers' jobs eliminated. And that you are

providing more services to more people with fewer staff and resources.

Is it any wonder that our Bargaining Committees are profoundly frustrated and our members increasingly angry and disillusioned?

With the media on hand, we're hopeful the Premier and his government got our message: **a fair and reasonable offer is not too much to ask!**

### Ratification Review

Members of **St. Amant Community Residential Programs** (Local 178) voted overwhelmingly for strike action in March. As a result, their Committee was able to send a strong message when they returned to the table with the employer. After a tentative agreement was reached, members ratified a new contract in May.

**The University College of the North** (Locals 69 and 70) Bargaining Committee, whose members voted to reject a tentative agreement in December, returned to the table with the employer in March, and will be voting on whether to accept the employer's final settlement offer on June 10 and 15, 2015.

**The Child and Family Services Central MB (Supervisors)** (Local 264) Bargaining Committee and the employer recently reached a tentative agreement, which the members will have a chance to vote on June 10, 2015.

### Strike Watch

After reaching an impasse with the employer, the newly merged **Liquor and Gaming Authority** (Locals 425 and 426) Bargaining Committee has called a strike vote for June 9, 2015 in Winnipeg and Brandon.

Meanwhile, 120 members of **Family Visions** (Local 303) in Brandon, who recently voted to reject a final offer, are also poised for a strike vote.

A few weeks ago, I expressed our members' concerns about the state of rural emergency medical services on the **Winnipeg Free Press** editorial page.

Many Manitoba paramedics are continuing to leave their communities for Winnipeg or other provinces where wages are better and working hours are shorter and more predictable. Manitoba is also not graduating enough paramedics to take the place of those that leave, meaning ambulances needed in rural areas are increasingly unavailable due to staffing shortages.

This can't go on. The recommendations of the **EMS Review** must be implemented now!
